- 1. Nature of work: Solving sensational crime

On 15/05/2017, a naked unknown dead body of a women aged around 25 years was found floating in Chattri Talav, an area under Rajapeth P.S., Amravati City. The body was decomposed, naked and unidentified. On receiving the Information, officers and staff of Rajapeth P.S. and Crime Branch visited the crime scene. On close inspection, we found sharp injuries on the neck and a tattoo mark on the hand of the deceased. Accordingly we registered a complaint under IPC S. 302 and the investigation started.

Firstly, we tried enquiring in the area surrounding Chattri Talay, if any woman was missing. Not succeeding, we expanded our search. And checked records of all missing registered in all police stations in City and Amravati rural. We short-listed around ten missing complaints. Coincidentally, one missing registered in Rajapeth P.S. matched to the description of the deceased found. Finally, we were able to identify the body as one Neeta Dilip Ingole, r/o Hamalpura. Her husband, Dilip and other relatives had given her missing complaint some days ago. On enquiry, it came to our notice that the victim was a housewife and had regular fights with Dilip. He was suspicious about her character. But his presence while registering the missing and calm behavior did not reveal anything. We started enquiring with her relatives, neighbors and Dilip. First step was to check mobile details, CDR/SDRof the deceased and her relatives. One principle we adopted was that, while interrogating each person we made sure that the CDR reports were studied carefully. While interrogating Dilip, it came to fore that the deceased and Dilip had traveled to various locations on the day before she went missing. On questioning, he faltered about his purpose of being at certain locations. And this was the break-through that he was hiding something. Finally on persistent probing, he admitted to have committed the crime.

As per his version, the deceased was in an illicit relation with her nephew, Akash. When Dilip came to know about it, he planned to kill her. On the day of the murder he took her to different locations to find a suitable place to kill her. Finally, he found a secluded area near Chattri Talav and attacked her using a sharp knife. Ensuring she was dead he removed her clothes and burnt them. He found a cloth nearby the place and he put a heavy stone in it, tied it to her body and pushed her into the lake to destroy evidence.

Currently the accused is arrested. His motorcycle, mobile phone and weapon have been seized. Also ashes of the burnt clothes recovered.

The case was investigated by PI Kishor Suryawanshi, Rajapeth P.S. with assistance of API Kanchan Pande, Cyber Cell and others, under the guidance of Shri Dattatray Mandlik, Commissioner of Police and DCP Zone-1 Shri. Shashikant Satao.
